ORDINANCE NO.

1 AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD
2 COUNTY, FLORIDA, PERTAINING TO ETHICS; AMENDING SECTION 1-19 OF THE
3 BROWARD COUNTY CODE OF ORDINANCES (“CODE”); AMENDING SECTION 26-73
4 OF THE CODE; SUPERSEDING CONFLICTING ORDINANCES; AND PROVIDING
5 FOR SEVERABILITY, INCLUSION IN THE CODE, AND AN EFFECTIVE DATE.

8 WHEREAS, Chapter 112, Part III, Florida Statutes, provides a Code of Ethics for
9 Public Officers and Employees (“Florida Code of Ethics”), which applies to members of
10 the Broward County Board of County Commissioners (the “Board”), County employees,
11 and mayors and members of governing bodies of municipalities within Broward County
12 (“Municipal Officials”);

13 WHEREAS, Section 112.326, Florida Statutes, empowers local governments to
14 impose more stringent ethical standards than are provided under the Florida Code of
15 Ethics;

16 WHEREAS, pursuant to the Broward County Charter, the Board enacted
17 Section 1-19 of the Broward County Code of Ordinances, known as the Code of Ethics
18 for Elected Officials (“County Code of Ethics”), which imposes more stringent ethical
19 standards than the Florida Code of Ethics, including more stringent gift limitations;

20 WHEREAS, the Florida Code of Ethics, in most instances, permits public officials
21 who are subject to its gift limitations to accept gifts worth \$100.00 or less from donors

22 who lobby or do business with their agencies, thus allowing most public officials to interact
23 with the public in situations where items of nominal value may be exchanged, while still
24 prohibiting sizable gifts that may invite actual or perceived impropriety;

25 WHEREAS, the stringent gift limitations in the County Code of Ethics
26 unintentionally discourage personal interaction and communication between elected
27 officials and the communities they serve, and under certain circumstances impose
28 unnecessary costs on City and County governments to pay for elected officials' admission
29 to or participation in relevant events that would otherwise not require public expenditure;
30 and

31 WHEREAS, the Board finds that modifying the County Code of Ethics as provided
32 below will improve understanding of, and compliance with, the law and promote
33 communication and interaction between local governments and the communities they
34 serve, thus strengthening the County Code of Ethics, and further finds that such
35 modification is in the best interest of the County,

36 BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF
37 BROWARD COUNTY, FLORIDA:

38 Section 1. Section 1-19 of the Broward County Code of Ordinances is hereby
39 amended to read as follows:

40 **Sec. 1-19. Code of ethics for elected officials.**

41 . . .

42 (c) *Standards of Conduct.* In addition to the provisions of Chapter 112, Part III,
43 Florida Statutes, Code of Ethics for Public Officers and Employees; Chapters 838 and
44 839, Florida Statutes; Title 18, Chapter 63 of the United States Code; and Chapter 26,

45 Article V of the Broward County Code of Ordinances, Section 26-67, et seq., the following
46 Standards of Conduct shall apply to each Elected Official:

47 (1) *Acceptance of gifts.*

48 a. No Elected Official or relative, registered domestic partner, or
49 governmental office staff of any Elected Official, shall accept ~~any gift,~~
50 directly or indirectly, any gift of food and/or nonalcoholic beverages
51 with a value in excess of \$25.00 or any other gift with a value in
52 excess of \$5.00, from lobbyists registered with the governmental
53 entity on whose behalf they (or their registered domestic partner or
54 relative) serve, or from any principal or employer of any such
55 registered lobbyist, or from vendors or contractors of such
56 governmental entity. In order to effectuate this provision, no lobbyist
57 shall engage in any lobbying activity prior to registering as a lobbyist
58 with the applicable governmental entity. For purposes of this
59 paragraph, neither Broward County, any municipality within Broward
60 County, nor any other governmental entity shall be considered a
61 registered lobbyist, a principal or employer of a registered lobbyist,
62 or a vendor or contractor of any governmental entity within Broward
63 County.

64 . . .

65 Section 2. Section 26-73 of the Broward County Code of Ordinances is hereby
66 amended to read as follows:

67 **Sec. 26-73. Code of Ethics.**

68 (a) Solicitation or Acceptance of Gifts.
69 (1) County employees shall not solicit or accept any gift, regardless of value, in
70 their official capacity as employees, nor shall they solicit or accept any gift
71 in either an official or personal capacity that may be reasonably perceived
72 to be given to encourage or discourage them from taking any action in
73 connection with their County employment.

74 . . .

75 (6) Notwithstanding Section 26-73(a)(1), the office staff of County
76 Commissioners may, with written approval of the County Commissioner for
77 whom the staff member works, accept gifts of food and/or nonalcoholic
78 beverages with a value not greater than \$25.00.

79 . . .

80 Section 3. Conflicting Earlier Ordinances Superseded.

81 To the extent any provision of this Ordinance, including its manner of enactment
82 by a simple majority vote of the Board, conflicts with Ordinance No. 2010-22,
83 Ordinance No. 2011-19, or Ordinance No. 2015-55, this Ordinance supersedes and
84 amends said earlier ordinances solely to the extent of such conflict.

85 Section 4. Severability.

86 If any portion of this Ordinance is determined by any court to be invalid, the invalid
87 portion will be stricken, and such striking will not affect the validity of the remainder of this
88 Ordinance. If any court determines that this Ordinance, in whole or in part, cannot be
89 legally applied to any individual, group, entity, property, or circumstance, such

90 determination will not affect the applicability of this Ordinance to any other individual,
91 group, entity, property, or circumstance.

92 Section 5. Inclusion in the Broward County Code of Ordinances.

93 It is the intention of the Board of County Commissioners that the provisions of this
94 Ordinance become part of the Broward County Code of Ordinances as of the effective
95 date. The sections of this Ordinance may be renumbered or relettered and the word
96 “ordinance” may be changed to “section,” “article,” or such other appropriate word or
97 phrase to the extent necessary to accomplish such intention.

98 Section 6. Effective Date.

99 This Ordinance is effective as of the date provided by law.
