

SECOND AMENDMENT TO AGREEMENT BETWEEN BROWARD COUNTY AND UNIVERSAL PROTECTION SERVICE, LLC D/B/A ALLIED UNIVERSAL SECURITY SERVICES, LLC FOR SECURITY SERVICES AT FORT LAUDERDALE-HOLLYWOOD INTERNATIONAL AIRPORT (RFP# GEN2120413P1)

This Second Amendment ("Amendment") is entered into by and between Broward County, a political subdivision of the State of Florida ("County"), and Universal Protection Service, LLC d/b/a Allied Universal Security Services, LLC, a Delaware limited liability company registered to transact business in the State of Florida ("Contractor") (each a "Party" and collectively referred to as the "Parties").

RECITALS

- A. On November 22, 2022, the Parties entered into the Agreement between Broward County and Universal Protection Service, LLC d/b/a Allied Universal Security Services, LLC for Security Services at Fort Lauderdale-Hollywood International Airport (RFP# GEN2120413P1) ("Original Agreement").
- B. The Original Agreement was amended by a First Amendment, executed on November 27, 2024, which, among other things, required Contractor to contribute an additional \$0.30 per hour to the Building Service 32BJ Health Fund (as defined in the First Amendment) for hours worked by certain employees during Contract Year 2 and adjusted Contractor's compensation to reimburse Contractor for such additional costs. The Original Agreement as amended by the First Amendment is referred to herein as the "Agreement."
- C. The Parties now desire to further amend the Agreement to increase the not-to-exceed amounts for Contract Year 3, Contract Year 4, and Contract Year 5, and to increase the estimated hours for certain Services.

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

- 1. The above Recitals are true and correct and are incorporated herein by reference. All capitalized terms not expressly defined within this Amendment shall retain the meaning ascribed to such terms in the Agreement.
- 2. Except as modified herein, all remaining terms and conditions of the Agreement shall remain in full force and effect.
- 3. Section 5.1 of the Agreement is amended as follows (strikethroughs indicate deletions and bolding/underlining indicates additions):
 - 5.1 <u>Maximum Amounts</u>. For all services provided under this Agreement, County will pay Contractor up to a maximum amount as follows:

Payment shall be made only for Services actually performed and completed pursuant to this Agreement as set forth in **Exhibit B** (Payment Schedule), which amount shall be accepted by Contractor as full compensation for all such Services. Contractor acknowledges that the amounts set forth in this Agreement are the maximum amounts payable and constitute a limitation upon County's obligation to compensate Contractor for Services. These maximum amounts, however, do not constitute a limitation of any sort upon Contractor's obligation to perform all Services.

- 4. **Exhibit B** is replaced by **Exhibit B** as attached hereto, which is incorporated in the Agreement. Amendments to **Exhibit B** made pursuant to this Amendment are indicated by use of strikethroughs to indicate deletions and bolding/underlining to indicate additions. All references to **Exhibit B** in the Agreement are deemed to refer to the **Exhibit B** as attached hereto.
- 5. In the event of any conflict or ambiguity between this Amendment and the Agreement, the Parties agree that this Amendment shall control. The Agreement, as amended herein by this Amendment, incorporates and includes all prior negotiations, correspondence, conversations, agreements, and understandings applicable to the matters contained herein, and the Parties agree that there are no commitments, agreements, or understandings concerning the subject matter hereof that are not contained in the Agreement as amended by this Amendment. Accordingly, the Parties agree that no deviation from the terms hereof shall be predicated upon any prior representations or agreements, whether oral or written.
- 6. Preparation of this Amendment has been a joint effort of the Parties, and the resulting document shall not, solely as a matter of judicial construction, be construed more severely against one of the Parties than any other.
- 7. Contractor acknowledges that through the date this Amendment is executed by Contractor, Contractor has no claims or disputes against County with respect to any of the matters covered by the Agreement.
- 8. The effective date of this Amendment shall be the date that this Amendment is fully executed by the Parties.
- 9. This Amendment may be executed in multiple originals or in counterparts, whether signed physically or electronically; each of which shall be deemed to be an original, and all of which, taken together, shall constitute one and the same agreement.

All hours worked must be approved in writing through a Staffing Report.
