This memorandum supersedes the previous memorandum dated November 5, 2024.

The Office of Economic and Small Business Development (OESBD) has conducted a review of Broward County Builders JV CBE Participation as of January 31, 2025. This contract was awarded to Broward County Bridge Builders, a Joint Venture (JV), on June 1, 2021. This evaluation for Change Order No. 18 is for an additional work scope and an increase to an existing allowance account for unforeseen conditions. This increase the overall contract amount by \$3,081,153.90. from \$33,840,149.19 to \$36.921.303.09. The CBE goal for this contract is 4% and Broward County Bridge Builders JV has committed to 4.7% CBE participation. An overview is provided as follows:

CBE Compliance Comments:

Broward County Bridge Builder's current CBE participation is 3.29%, which is short of their commitment by 1.41%. In October 2024, OESBD requested and received a plan of action from the prime contractor that encompassed a forecast of future work scopes earmarked for CBE participation. OESBD has reviewed Broward County Bridge Builder's plan of action and sent the prime contractor the listing of certified CBE firms to contact for potential subcontracting opportunities. OESBD will continue to monitor the prime contractor's CBE commitment for the duration of the project.
