RESOLUTION DIRECTING THE COUNTY ADMINISTRATOR TO
PUBLISH NOTICE OF PUBLIC HEARING TO CONSIDER ADOPTION OF A
RESOLUTION AMENDING THE BROWARD COUNTY ADMINISTRATIVE CODE

BE IT RESOLVED by the Board of County Commissioners of Broward County,
Florida, that:

Section 1. The County Administrator in and for Broward County, Florida, and
ex officio Clerk of the Board of County Commissioners of Broward County is authorized
and directed to publish notice of intent of the Board of County Commissioners of Broward
County to consider at the public hearing on September 10, 2026, at 10:00 a.m., the
adoption of a Resolution Amending the Broward County Administrative Code, the title of
which is as follows:

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD
COUNTY, FLORIDA, PERTAINING TO WASTEWATER SERVICES; AMENDING
SECTION 38.20 OF THE BROWARD COUNTY ADMINISTRATIVE CODE
("ADMINISTRATIVE CODE") TO PRESCRIBE A REVISED SCHEDULE OF WASTEWATER
LARGE USER RATES; AND PROVIDING FOR SEVERABILITY, INCLUSION IN THE
ADMINISTRATIVE CODE, AND AN EFFECTIVE DATE.

Section 2. Such notice shall be made pursuant to the applicable provisions of
Section 3.04 of the Broward County Charter.

Section 3. This Resolution will take effect upon adoption.
