The Public Transportation Grant Agreement ("Agreement") between the Florida Department of Transportation ("Department") and Broward County ("Agency"), dated 11/10/2022, is scheduled to expire on the 31 day of December, 2025.

The Agency requests an Amendment of the Agreement, to extend the end date of the Agreement to the 30 day of September, 2026, for additional time to complete the Project for the following reasons: The project was divided into two phases due to conflicts with existing infrastructure—including utilities, gate access points, and landscaping—as well as the need to revisit the geometric layout of the path. Phase 1 encompasses approximately 65% of the total path, extending from the starting point to Oleander Drive. Phase 2 continues from Oleander Drive eastward to the end of the path. These design complexities led to delays in determining the appropriate course of action, which in turn impacted the timely completion of the 90% design documents for both phases. The 100% design submittal for Phase 1 was received on September 18, 2025, while the 100% submittal for Phase 2 is projected for November 26, 2025. Both phases are currently undergoing permit reviews, including FDOT review and drainage approvals from the South Florida Water Management District and the South Broward Drainage District. The requested extension will ensure adequate time to resolve these permitting processes and finalize the design, allowing the project to proceed without compromising quality or compliance.

The Department agrees to the requested extension of the Agreement. All of the terms and conditions of the Agreement and any amendments thereto shall remain in full force and effect.
