The purpose of this amendment is to increase the contract amount by \$300,000.00, increase the level of services accordingly, change the total contract funding from \$1,627,811.36 to \$1,927,811.36, and replace attachments.

(1) Section 4 is hereby amended to read as follows:

4. Contract Amount

The Council agrees to pay for contracted services according to the terms and conditions of this Contract in an amount not to exceed \$1,927,811.36 subject to the availability of funds. Any costs or services paid for under any other contract or from any other source are not eligible for payment under this Contract.

All provisions in the Contract and any attachments thereto in conflict with this amendment shall be and are hereby changed to conform to this amendment.

All provisions in the Contract not in conflict with this amendment are still in effect and are to be performed at the level specified in the Contract.

This amendment and all of its attachments are hereby made a part of the contract.
