

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, SUPPORTING THE NAMING OF BROWARD COUNTY'S NORTH BEACH PARK IN THE CITY OF HOLLYWOOD IN HONOR OF LATE COMMISSIONER SUZANNE GUNZBURGER.

WHEREAS, in 1982, Suzanne Gunzburger was elected to the City Commission of the City of Hollywood, and was subsequently re-elected in 1986 and 1990, having served the City for ten years; and

WHEREAS, in 1992, Commissioner Gunzburger was elected to the Broward County Board of County Commissioners, and was subsequently re-elected in 1994, 1998, 2002, 2006, and 2010, serving a total of 22 years, tying the record for the longest-serving County Commissioner in Broward County history; and

WHEREAS, during her tenure on the County Commission, Commissioner Gunzburger served as Commission Vice Chair, Commission Chair, Broward County Vice Mayor, and Broward County Mayor; and

WHEREAS, Commissioner Gunzburger also worked as a clinical marriage and family counselor, a public school teacher, and a small businesswoman; and

WHEREAS, Commissioner Gunzburger was a fierce advocate for efficient and ethical government; protection of natural and historical resources; and providing services for the health and well-being of families and children; and

WHEREAS, during her nearly four decades of elected public service, Commissioner Gunzburger was recognized with numerous awards for her significant and varied contributions to Broward County and the City of Hollywood; and

WHEREAS, the Broward County Board of County Commissioners is considering a request to rename North Beach Park, located within the City of Hollywood, in honor of the late Commissioner Suzanne Gunzburger's life and legacy.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:
