1 A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD
2 COUNTY, FLORIDA, PLACING CERTAIN CONSERVATION LAND AND GREEN
3 SPACE SITES ON THE BROWARD COUNTY URBAN WILDERNESS INVENTORY
4 PURSUANT TO SECTION 25½-27, BROWARD COUNTY CODE OF ORDINANCES;
5 AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

7 WHEREAS, the Broward County Parks and Recreation Division recommends
8 placement of 17 conservation land and green space sites on Broward County's Urban
9 Wilderness Inventory ("Inventory") pursuant to Section 25½-27, Broward County Code of
10 Ordinances;

11 WHEREAS, all 17 sites are considered equally high priorities by the Urban
12 Wilderness Advisory Board for inclusion on the Inventory and subsequent designation as
13 wilderness areas; and

14 WHEREAS, under the County's current designation process, inclusion in the
15 Inventory will allow for additional due diligence to be performed and for the Commission
16 to later consider, based on that additional due diligence, whether all or some of these
17 sites should be designated as wilderness areas within the Urban Wilderness Park
18 System, NOW, THEREFORE,

19 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
20 BROWARD COUNTY, FLORIDA:

Section 1. The Board of County Commissioners of Broward County, Florida, hereby places the seventeen (17) sites described in Exhibit A, attached hereto, on the County's Urban Wilderness Inventory pursuant to Article II of Chapter 25½, Broward County Code of Ordinances.

Section 2. Severability.

If any portion of this Resolution is determined by any court to be invalid, the invalid portion will be stricken, and such striking will not affect the validity of the remainder of this Resolution. If any court determines that this Resolution, in whole or in part, cannot be legally applied to any individual, group, entity, property, or circumstance, such determination will not affect the applicability of this Resolution to any other individual, group, entity, property, or circumstance.

Section 3. Effective Date.

This Resolution is effective upon adoption.

Re: Broward County Urban Wilderness Inventory for Designation

Dear Commissioners:

Per Section 25½ of the Broward County Code of Ordinances, the Urban Wilderness Advisory Board (UWAB) has been tasked with recommending natural areas to be set aside as permanent preserves. The first step in this process is the placement of eligible sites on the Urban Wilderness Inventory. Once a site is placed on the Inventory, it may then be designated as part of the Broward County Urban Wilderness Park System by ordinance of the Board of County Commissioners.

The UWAB recommends that the Board of County Commissioners add the following sites to the Urban Wilderness Inventory. All sites are considered of equally high priority by the UWAB for inclusion on the Inventory and subsequent designation as wilderness areas.
