ARTICLE VI. CITY MANAGER

Sec. 6.01. Administrative powers.

The city manager shall be the administrative head of the city government and shall be responsible for the efficient administration of all departments of the city.

(Ord. O-84-14, passed 2-3-84)

Sec. 6.02. Term; salary.

(a) The city manager shall be appointed by a majority vote of the commission for an indefinite term. The commission shall hold an annual review of the city manager at a public meeting.

(b) The city manager shall hold office at the will of the commission and shall receive such salary as may be fixed by the commission.

Sec. 6.03. Absence from duties.

At no time shall be a vacancy in the position of city manager. In case of the unexcused absence of the city manager for a period in excess of 90 days, the commission may appoint another person, not a member of the commission, to act for the city manager during such sickness or absence. The person so appointed may, during such tenure, act for the city manager and perform all his or her duties and all of such acts of the person so appointed shall be as valid as those performed by the city manager. In all other situations, the city manager shall name a temporary acting city manager.

Sec. 6.04. Powers and duties.

The powers and duties of the city manager shall be:

(1) To see that the laws and ordinances are enforced.

(2) To appoint and remove, except as otherwise provided, all subordinate officers and employees.

(3) To exercise control over all departments that may be created by the commission.

(4) To attend all meetings of the commission with the right to take part in the discussion but having no vote.

(5) To recommend to the commission for adoption such measures as he or she may deem necessary or expedient.

(6) To keep the commission fully advised as to the general condition of the city, including but not limited to its financial condition, and to submit annually a budget.

(7) To perform such other duties as may be required of him or her by ordinance or resolution of the commission.
