RESOLUTION NO.

1 A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD
2 COUNTY, FLORIDA, AUTHORIZING THE MAYOR TO EXECUTE A PUBLIC
3 TRANSPORTATION GRANT AGREEMENT WITH THE FLORIDA DEPARTMENT OF
4 TRANSPORTATION, DISTRICT 4, IN THE AMOUNT OF \$10,904,807, WHICH
5 BROWARD COUNTY IS REQUIRED TO MATCH, FOR A TOTAL PROJECT COST OF
6 \$21,809,614, TO PROVIDE FISCAL YEAR 2024 BLOCK GRANT FUNDING
7 ASSISTANCE TO BROWARD COUNTY FOR PUBLIC TRANSPORTATION
8 OPERATING COSTS; AUTHORIZING THE COUNTY ADMINISTRATOR TO TAKE ALL
9 NECESSARY ADMINISTRATIVE AND BUDGETARY ACTIONS; AND PROVIDING FOR
10 AN EFFECTIVE DATE.

12 WHEREAS, Section 341.052, Florida Statutes, created the public transit block
13 grant program administered by the Florida Department of Transportation ("FDOT");

14 WHEREAS, the public transit block grant program provides funding to public transit
15 providers to assist with operating costs for the provision of public transit services;

16 WHEREAS, Broward County is a recipient of public transit block grant funds;

17 WHEREAS, on November 15, 2022 (Item No. 11), the Broward County Board of
18 County Commissioners approved Resolution No. 2022-513 adopting the Broward County
19 Transit Development Plan 2023-2032 Annual Update;

20 WHEREAS, based upon the Broward County Transit Development Plan
21 2023-2032 Annual Update, FDOT approved Ten Million Nine Hundred Four Thousand
22 Eight Hundred Seven Dollars (\$10,904,807) in State Fiscal Year 2024 public transit block
23 grant funds for Broward County Transportation Department operating expenses, which

24 the County is required to match, for a total project cost of Twenty-one Million Eight
25 Hundred Nine Thousand Six Hundred Fourteen Dollars (\$21,809,614); and

26 WHEREAS, the Public Transportation Grant Agreement must be approved by the
27 transit agency's governing body, NOW, THEREFORE,

28 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
29 BROWARD COUNTY, FLORIDA:

30 Section 1. The Board of County Commissioners of Broward County, Florida (the
31 "Board"), authorizes its Mayor to execute the Public Transportation Grant Agreement
32 ("PTGA") with FDOT, District 4, attached as Exhibit 1, in the amount of Ten Million Nine
33 Hundred Four Thousand Eight Hundred Seven Dollars (\$10,904,807) in State Fiscal Year
34 2024 public transit block grant funds for Broward County Transportation Department
35 operating expenses, which the County is required to match, for a total project cost of
36 Twenty-one Million Eight Hundred Nine Thousand Six Hundred Fourteen Dollars
37 (\$21,809,614), granted under Financial Project No. 407186-3-84-01, to provide funding
38 for public transportation operating expenses for the project.

39 Section 2. The Board authorizes the County Administrator to take all necessary
40 administrative and budgetary actions to implement the PTGA.
