This is an agreement, made and entered into by and between: BROWARD COUNTY ("COUNTY"), a political subdivision of the state of Florida,

AND

TAMARAC INDUSTRIAL VENTURE LLC, a Delaware limited liability company, and its

successors and assigns ("DEVELOPER").

WITNESSETH

WHEREAS, COUNTY, by and through its Resilient Environment Department ("Department"), shall or has issued License No. <u>DF20-1214</u> ("License"), to DEVELOPER; and

WHEREAS, one of the conditions of approval of the License was establishing financial assurances by DEVELOPER for compliance with certain monitoring and maintenance ("Monitoring and Maintenance") of mitigation areas required to be installed or enhanced pursuant to the License; and

WHEREAS, DEVELOPER desires to provide to the COUNTY a Cash Bond, payable to the Broward County Board of County Commissioners, as a replacement financial assurance to secure the Monitoring and Maintenance; NOW, THEREFORE,

In consideration of the mutual terms, conditions, promises, covenants, and payments hereinafter set forth, COUNTY and DEVELOPER agree as follows:

1. DEVELOPER shall bond for the actual Monitoring and Maintenance requirements set forth in the License.

- 2. DEVELOPER is responsible for carrying out the actual Monitoring and Maintenance requirements as set forth in the license.
- 3. The estimated costs of the Monitoring and Maintenance are, <u>Thirty-five</u> thousand four hundred twenty and no/100 Dollars (\$35,420.00).
- 4. The Monitoring and Maintenance requirements shall be secured by cash, check (cashier's, certified, or registered), or money order issued by <u>BB&T</u> (financial institution), a copy of which is attached hereto as Exhibit "A", in the amount of <u>Thirty-five</u> <u>thousand four hundred twenty and no/100</u> Dollars (\$35,420.00), payable to the Broward County Board of County Commissioners. The DEVELOPER may, at its option, later provide to the COUNTY a surety bond or letter of credit in like amount acceptable to COUNTY to be substituted for the cash, check, or money order.
- 5. If the DEVELOPER should fail to carry out the Monitoring or Maintenance required, the COUNTY may, in addition to all other remedies available at law and equity, draw upon the Cash Bond and use the funds for Monitoring or Maintenance required by the License.
- 6. Upon completion of the Monitoring and Maintenance, the DEVELOPER shall notify the Department of such completion and, upon a determination in writing to DEVELOPER by the Department that the Monitoring and Maintenance required by the License has been completed, the COUNTY shall have ninety (90) days from the date of such determination to remit <u>Thirty-five thousand four hundred twenty and no/100</u> Dollars (\$35,420.00) to the DEVELOPER, provided that the COUNTY has not already effected a remittance to the DEVELOPER because of the earlier substitution of a surety bond or a letter of credit.
- 7. Remittance to DEVELOPER of any contingency fee required to be paid will be done in accordance with the License.
