SUBJECT: Request for Contract Threshold Increase for Contract No. TR2122622B1, Bus Parts and Supplies

The Broward County Transportation Department (BCT) is requesting a threshold increase in the amount of \$4,000,000.00 for Contract No. TR2122622B1, Bus Parts and Supplies.

The above referenced open-end contract with multiple vendors provides replacement bus parts to support maintenance repairs to the Operation Division bus fleet. This contract began on August 24, 2021, for an initial one-year period at an estimated annual amount of \$6,500,000 with two one-year renewal options for a total of three years at an estimated threshold amount of \$19,500,000. On May 2, 2023, Item No. 12, the Board approved a \$3,000,000 threshold increase, revising the three-year contract amount to \$22,500,000.

BCT is requesting an additional contract threshold increase for Contract No. TR2122622B1 in the amount of \$4,000,000 due to aging fleet, 2018-2021 buses out of warranty, and inflation. This amount will be added to the contract amount to allow us to purchase parts necessary to properly maintain and continue repairing our bus fleet to a state of good repair. The current monthly expenditures are attached.
