The Agreement is hereby modified as follows:

For purposes of this Contract Adjustment, pursuant to Article 4, Section 4.4, "Contract Adjustments" of the Agreement, the maximum funding for the Initial Term is decreased to Seven Hundred Eighty-eight Thousand Seven Hundred Eighty-eight Dollars (\$788,788).

For purposes of this Contract Adjustment, Pursuant to Article 4, Section 4.2, "Reduction of Funds" of the Agreement, Exhibit A "Agreement Specifications," Section III.A., "Maximum Funding Amounts" is amended to read as follows:

- III. Maximum Funding Amounts:
  - A. Initial Term: \$788,788

For purposes of this Contract Adjustment, pursuant to Article 4, Section 4.5 "Method of Payment," Exhibit D-1, Scope of Services, Section I.C., for Program 1, Mental Health Services - Outpatient, is amended to read as follows:

- I. Scope of Services
  - C. A minimum of 315 unduplicated Clients must be provided services under this Agreement annually.

For purposes of this Contract Adjustment, pursuant to Article 4, Section 4.5 "Method of Payment," Exhibit D-1, Scope of Services, Section II.B., "Maximum Number of Units to be Purchased/Maximum Dollar Amount" for Program 1, Mental Health Services - Outpatient, is amended to read as follows:

- II. Maximum Number of Units to be Purchased/Maximum Dollar Amount:
  - B. \$ Amount for the Initial Term: \$381,491
