**SUBJECT**: No CBE Goal Mosquito Control Chemicals

Broward County is seeking a vendor to furnish and deliver Mosquito Control Chemicals for the Broward County Highway and Bridge Maintenance Division's Mosquito Control Section. All chemicals must be approved by the Florida Department of Agriculture, Consumer Services, the Environmental Protection Agency (EPA) and comply with OSHA 29 CFR 1910.147, OSHA 29 CFR 1910.1200 and Chapter 442, of the Florida Statutes.

A review of the Small Business Certified Firm Directory revealed seven (7) certified County Business Enterprise (CBE) that provide extermination and pest control services, but none of them are retailers, wholesalers, or authorized distributors of mosquito control chemicals. Therefore, consistent with the Broward County Business Opportunity Act, as amended, Sec. 1-81.3 (1) (a), if there are fewer than two (2) certified CBEs available to participate in a specific project, no CBE goal will be applicable.

## This contract is not subject to the Broward County Construction Apprenticeship Program.
