A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA ("BOARD"), AUTHORIZING A PUBLIC HEARING REGARDING PETITION NO. 2023-V-04; RELEASING A PORTION OF A RIGHT-OF-WAY EASEMENT (OFFICIAL RECORDS BOOK 4673, PAGE 953); RELEASING A 75-FOOT PERPETUAL RIGHT-OF-WAY EASEMENT (OFFICIAL RECORDS BOOK 383, PAGE 453); ABANDONING A RIGHT-OF-WAY RECORDED IN MISCELLANEOUS PLAT BOOK 6, PAGE 23, ALL OF THE PUBLIC RECORDS OF BROWARD COUNTY; AND DIRECTING THE CLERK TO PUBLISH NOTICE OF SUCH HEARING.

WHEREAS, it has been requested that the Board of County Commissioners of Broward County, Florida ("Board"), (i) release a portion of a right-of-way easement granted by the Deed recorded at Official Records Book 4673, Page 953, of the Public Records of Broward County, Florida; (ii) release a 75-foot-wide perpetual right-of-way easement granted by the Deed recorded at Official Records Book 383, Page 453, of the Public Records of Broward County, Florida; and (iii) abandon that certain right-of-way recorded in Miscellaneous Plat Book 6, Page 23, of the Public Records of Broward County, Florida, said lands situate, being, and lying in Broward County, Florida, and described in Exhibit A, attached hereto;

WHEREAS, pursuant to Sections 27.68 the Broward County Administrative Code, this Board is required to hold a public hearing before said property may be released; and

28 and abandonment of these interests.

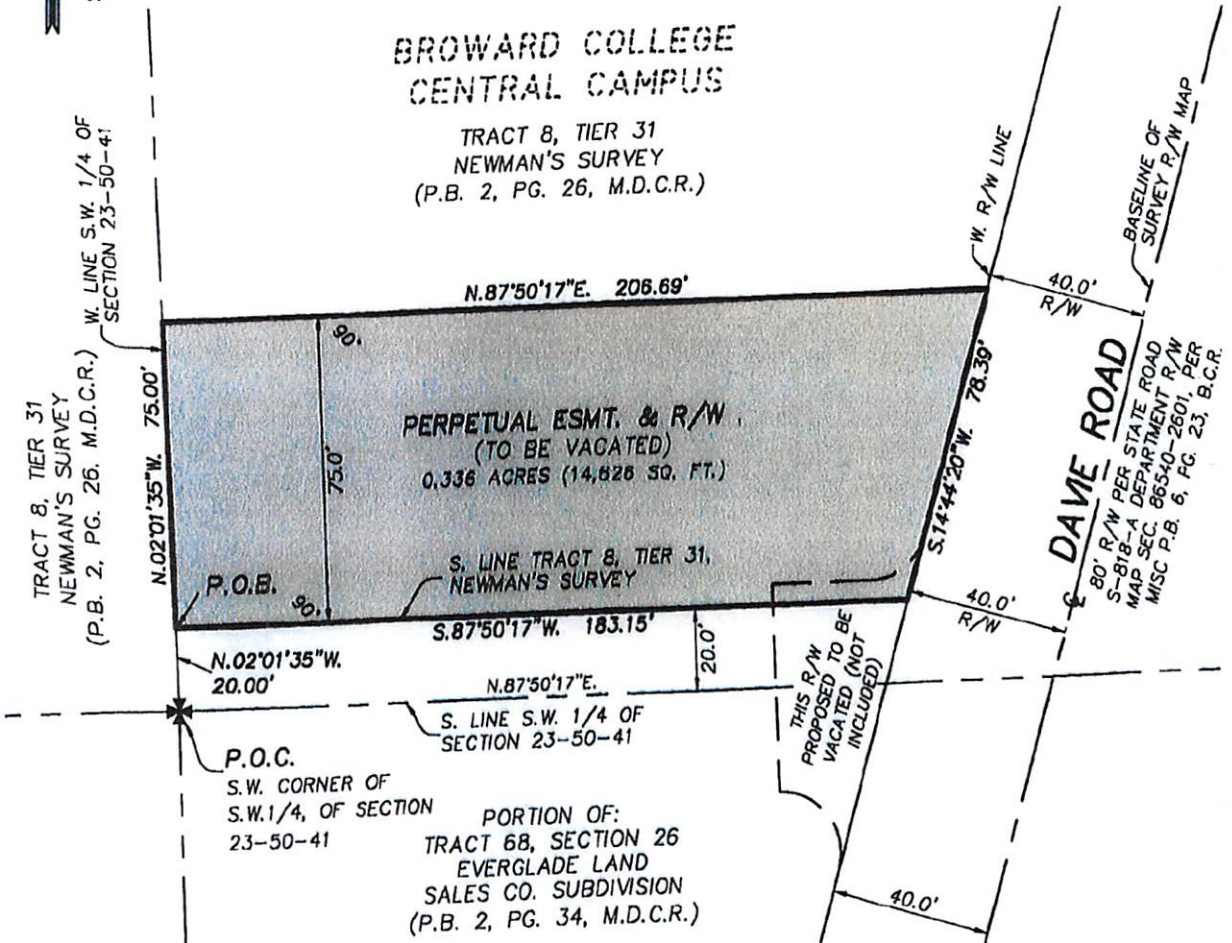

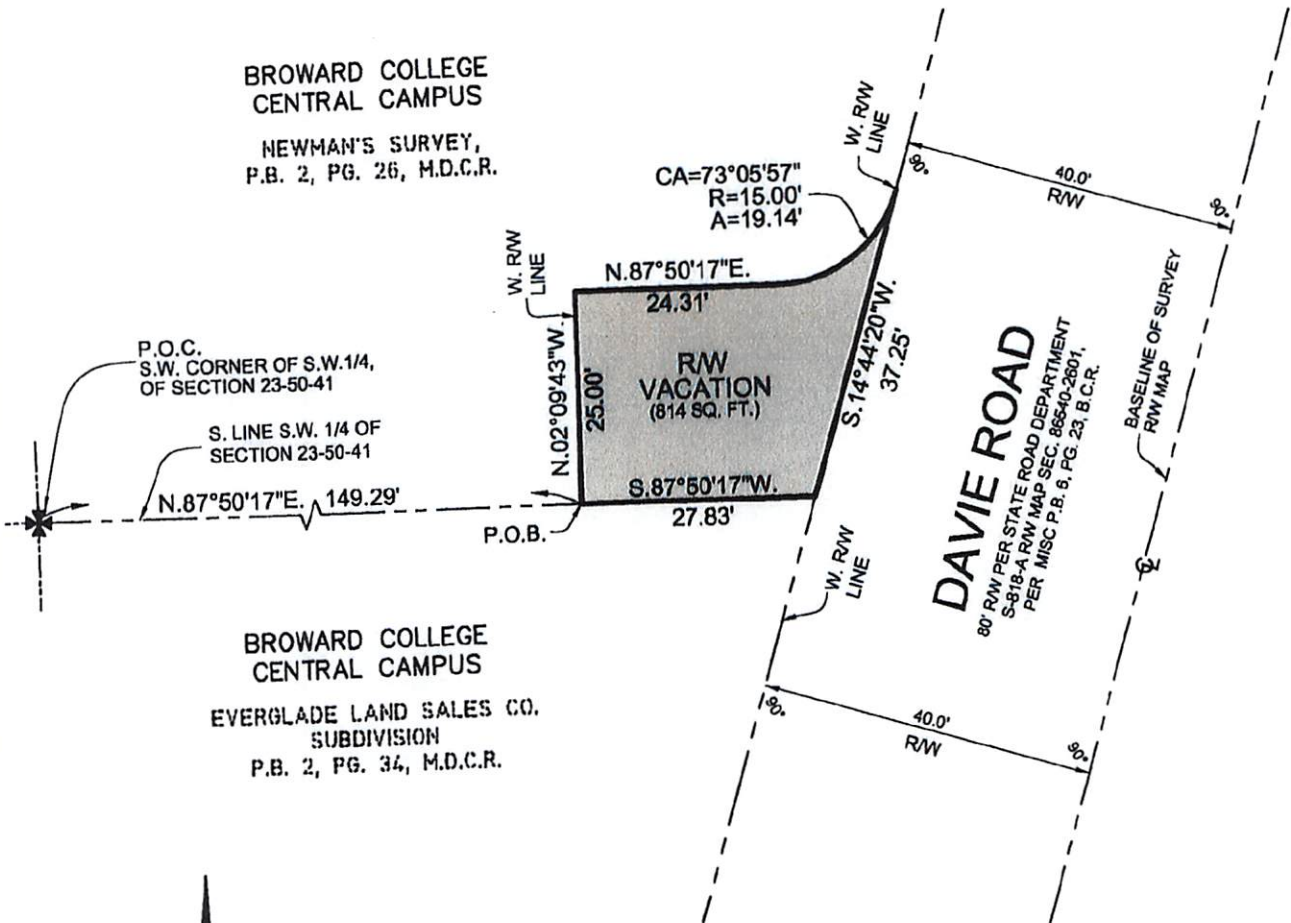

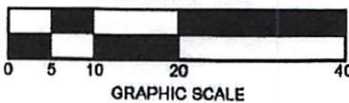
