Existing Right-of-Way Dedication:	The plat was approved with a requirement of a right-of-way dedication from Highway Construction and Engineering Division to be as follow:  Forty-five (45) feet of right-of-way to comply with the Broward County Trafficways Plan on Powerline Road, a 200-foot arterial.			
Proposed Right-of-Way Dedication:	Upon a further review of the arterial being 144-foot, the applicant is proposing to shift the east line of the Forty-five (45) feet of right-of-way dedication to the west by 6 feet, thereby amending the requirement of the right-of-way dedication from Highway Construction and Engineering Division to be as follow:  Thirty-nine (39) feet of right-of-way to comply with the Broward County Trafficways Plan on Powerline Road, a 144-foot arterial at this location.
