2 A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD
3 COUNTY, FLORIDA, AUTHORIZING A PUBLIC HEARING REGARDING VACATION
4 PETITION NO. 2023-V-01, VACATING AND ANNULLING A 24 FOOT-WIDE ACCESS
5 EASEMENT LYING WITHIN PARCEL A OF HUOK PLAT (PLAT BOOK 183,
6 PAGE 446), AND DIRECTING THE CLERK TO PUBLISH NOTICE OF SUCH HEARING.

8 WHEREAS, it has been requested that the Board of County Commissioners of
9 Broward County, Florida ("Board"), vacate and annul a 24-foot-wide access easement
10 lying within Parcel A of Hurok Plat, as recorded in Plat Book 183, Page 446, of the Public
11 Records of Broward County, Florida, and generally located on the northeast corner of
12 North Powerline Road and Northwest 9 Street in the City of Pompano Beach, Florida,
13 said lands situate, being, and lying in Broward County, Florida, and described in Exhibit
14 A, attached hereto; and

15 WHEREAS, pursuant to Section 177.101, Florida Statutes, and Chapter 5,
16 Article IX, of the Broward County Code of Ordinances, this Board is required to hold a
17 public hearing before said property may be vacated and annulled, NOW, THEREFORE,

18 BE IT RESOLVED by the Board that a public hearing shall be held at 10:00 a.m.,
19 on August 22, 2023, in Room 422 of the Broward County Governmental Center, located
20 at 115 South Andrews Avenue, Fort Lauderdale, Florida, to consider the vacation and
21 annulment of this interest.

22 BE IT FURTHER RESOLVED that the Clerk of this Board be and is hereby
23 authorized and directed to publish said notice of public hearing in the Sun-Sentinel
24 newspaper at least two (2) weeks prior to said date, inviting interested persons to appear
25 and be heard at the place and time herein specified.
