**CBE Compliance Comments:**

The current level of CBE participation on the agreement is 32.53%. Participation was verified through an independent payment verification process.

A 20% Minority/Women Business Enterprise (M/WBE) participation goal was initially established for this project and Olsen Associates, Inc. committed to 20% M/WBE participation at the time of award. As of the Sixth Amendment to this agreement, Broward County implemented its local County Business Enterprise (CBE) small business program, which replaced the M/WBE program. Consequently, OESBD established a 20% CBE goal for the Sixth Amendment to the agreement. Olsen Associates, Inc. in turn committed to 20% CBE participation under its agreement, as of the Sixth Amendment.
